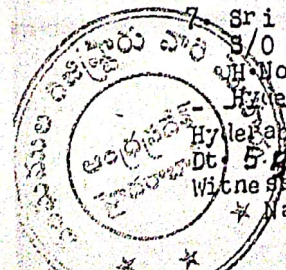

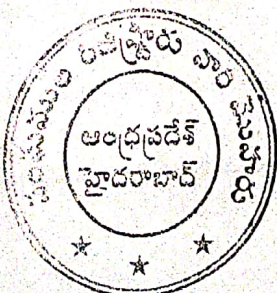

DOCUMENT NO. 2.

RULES AND REGULATIONS.

- 1) Name : St. Rita Educational Society.
- 2) Location : H.No.72, M.I.G., Bharatnagar, Hyderabad-500018.
- 3) Membership : There will be no caste or creed or class bar in admission of the member except that any person desirous becoming a member in the society should be an ordinary resident of the city.
- 2. General Membership, will be members who pay regularly the subscription mentioned herein who shall have right of vote in General Body and in other meetings.
- 3. Admission fee will be Rs.25/- (Rupees Twenty Five) for each member payable on or before 1st June of every year.
- 4) General Body and its functions:-
 - 1. To elect the executive body (Managing Committee) except the Secretary and Correspondent.
 - 2. To pass the budget for the ensuing year and approve the expenditure statement of the previous year.
 - 3. To approve the report of the activities of the Society.
 - 4. To appoint an auditor.
- 5. The General Body shall meet annually on the 5th of June of every year.
- 6. Executive body (Managing Committee and its functions:-
 - 1. The managing committee shall be composed of the President, the Vice-President the Secretary-cum-Correspondent, Organising Secretary, Treasurer and two members.
 - 2. All the members of the Managing Committee shall be elected persons from amongst the members, except the Secretary and Correspondent.
 - 3. The Managing Committee shall meet once in six months in the Academic year.
 - 4. The managing committee shall be elected for a period of Two years.
 - 5. The entire management of the school shall vest in the managing committee of the school and the committee shall exercise all the powers and discharge all the duties necessary for, or incidental to such management. (the school means created and managed by the Society).
 - 6. To ensure proper maintenance of accounts and safety of the properties of the school and Society.

- 7. To collect and receive subscription and donations or gifts from the members for the benefit of the sch maintained by the Society.
- 8. To submit the accounts for quit.
- 9. To place annual report before the General Body meetings.

7. Duties of the Office bearers:-

- 1. President: He shall, if present preside over all the meetings of t Committee. He may call for information from the Secretary in connecti with only matters effecting the Society. During the absence of the Secretary from the station or illne the president may either perform al the functions of the Secretary hims or appoint any member of the commi- tee to act as Secretary until he/S returns ~~and the~~
- 2. Vice-president: In the absence of t president, the Vice-president shall have all the fore-going powers of t ~~Secretary~~ President.
- 3. Secretary & Correspondent: She shall call meetings of the committees once in six months in the Academic year with the consultation of the presi- dent. She shall be the Chief Executi ve Officer of the Committees with powers to carry on the normal day to day administration of the Society an School and shall duly carry out the resolutions passed by the Committees

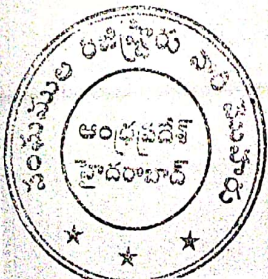
SHE shall on behalf of commi- tee be in-charge of the funds and properties and office of the school and Society, receive deposits, dis- burse monies, maintain, or cause to be maintained true and complete acc- counts of all receipts, Deposits and disbursements together with vouchers for the same, and necessary registers and shall have the accounts audited by the auditor appointed by the Committee.

SHE shall also act as the convenor and Secretary of every sub- committee appointed by the managing committee. She shall make proper arrangements for the safe custody of the papers, documents and records of the committee and shall prepare annual and other reports of the school and place them before the committee.

SHE shall be the manager and correspondent of the school for the purpose of all matters and correspon- dence with the government. She shall operate on the banking accounts of the school. She shall, generally, perform all such duties as may be ancillary to the duties specified above or as may be laid down by resolutions of the committee.

- 4. Organising Secretary: He shall be responsible for organising regular programmes of various activities approved by the managing committee and to organise day to day activities of the School and Society.
- 5. Treasurer: He should assist the Secretary in collecting monthly subscription and to maintain regular accounts, to prepare budget and balance sheet every year and present in the General Body and to get audited by the Society Accounts.
- 6. Managing Committee Members:- They will assist the office-bearers in the functioning of the society and must take part in the discussions, programmes, activities of the Society and School, and to help the Secretary in achieving the aims and objects of the Society.

8. QUORUM:
.....

4 members shall be deemed to be the quorum for the executive body meeting and 2/3rd for the General Body meeting and no business shall be transacted when there is quorum. No quorum is necessary for such adjourned meetings.

9. Funds:
.....

The funds shall be spent on the attainment of the objects of the society and no portion thereof shall be paid or transferred directly or indirectly to any of its members through any means.

10. Amendments:
.....

No amendment or alteration shall be made in purpose of the Association unless it is voted by 2/3rd members present at a meeting conveyed for the purpose and confirmed by 2/3rd of the members present at a second special meetings.

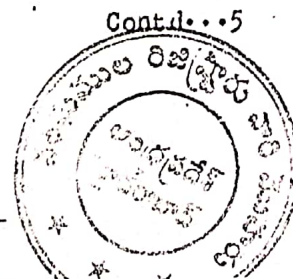
11. Removal:
.....

Any office bearer or member of the managing committee or General member can be removed or suspended from the post, if the General body specially convened for its purpose passes a resolution to that effect with 2/3rd majority of the members present.

12. Winding up:
.....

In case the society has to be wound up, the property and funds of the society that will remain after full satisfaction of the liabilities of the society or School will be transferred or paid to some other institution with similar aims and objects.

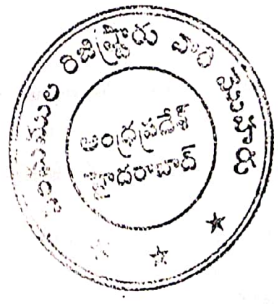

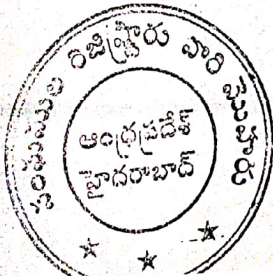
